Offers of employment include full time hours (35 hours/wk) and flexible part time hours. The positions will be scheduled to provide a mix of daytime, weekend and evening services.

#### **Who Are We?**

Regional HIV/AIDS Connection (RHAC) is a volunteer driven, non-profit, community-based organization serving the six counties surrounding London – Perth, Huron, Lambton, Elgin, Middlesex and Oxford. We are a community-inspired organization dedicated to enhancing the quality of life for individuals and diverse communities living with, at-risk for or affected by the challenges associated with HIV/AIDS. These Harm Reduction roles are responsible for engaging clients through outreach and in-reach activities, as well as educating individuals and communities, primarily through:

- Increasing knowledge about safer substance use practices
- Increasing access and use of Harm Reduction equipment and materials
- Providing Harm Reduction material/supplies to individual who use substances

- Liaising with other community services providers, maintain and support existing partnerships; develop new partnerships

**We want to hear from you if you:**

- Have working knowledge of addiction and have used Harm Reduction principles and approaches when supporting people in the community
- Understanding of societal stigma imposed on the substance using population and its related impacts
- Have excellent interpersonal and problem solving skills with strong written and oral communication skills
- Have experience with both individual and systemic advocacy
- Have crisis intervention/de-escalation skills
- Demonstrate strong organizational, time management skills with strong computer and data management skills
- Have knowledge of community resources and London social service agencies

**Qualifications**

- Direct experience with at risk populations and communities
- Post-secondary education in social services and/or experience providing education/support/counseling to adults
- Valid G Class driver's license for work-related duties and proof of insurance required
- Minimum three (3) years' experience working within the Harm Reduction model of service delivery
- Knowledge about HIV/HCV transmission, social determinants of health related issues
- Knowledge of different substances and social, physiological and behavioural impacts
- Training and rigorous application of safe sharps handling practices
- Basic First AID/CPR BLS/HCP, Crisis Intervention Training and will obtain a Vulnerable Persons Screening (Police Check)
