Strengthening Partnerships with Indigenous Organizations and Knowledge Keepers

Collaboration with Indigenous-led organizations and Elders is key to fostering culturally affirming, safe and community-driven solutions to HIV/AIDS and related health challenges. RHAC will actively build and maintain relationships with Indigenous service providers, grassroots initiatives, and knowledge keepers to ensure that our programs centering Indigenous perspectives, traditions, and needs. These partnerships will be rooted in mutual respect, shared learning, and the empowerment of Indigenous leadership when working on indigenous lands and with indigenous communities. We embrace Two-Eyed Seeing, a theoretical framework that acknowledges and gives equal consideration to Indigenous and non-Indigenous views of health and knowledge

Advocating for Equitable Access to HIV/HCV Related Healthcare and Harm Reduction Services for Indigenous Peoples

Indigenous communities continue to face significant health disparities due to systemic barriers and discrimination in healthcare settings. RHAC will advocate for policies and practices that promote equitable access to HIV and Hep C prevention, treatment, and harm reduction services. This includes working alongside Indigenous partners to remove barriers to care, supporting Indigenous-led health initiatives, and challenging stigma and discrimination that impact Indigenous Peoples seeking healthcare.
